

The 7th edition of **#EECONNECTED** takes place under the umbrella **Multimodal transport - 360° View - Better transport links. Better Business.**


Infrastructure – roads, railways, bridges, ports – is the foundation on which the economy is built. Better transport links can transform economies and drive growth for businesses.


With a complex agenda, and dynamic content, #EECONNECTED 2024 focuses on the transformation of the European transport networks, with a focus on the Balkan area.
